


595 To receive the report of the Ward Councillors - non

- 597 To receive a Schedule of Payments and Statement of Accounts for November 2020
Proposed by AC, seconded by PJM
- 598 To agree co-option of a Councillor - One application had been received and after discussion
AC and PJM agreed to decline this applicant to find a more local Resident before the next meeting
- 599 To agree the Precept - a rise of 25% was discussed with PJM querying the amount. The yearly
Outgoings were discussed and the need to be able to cover the costs for the new defibrillator once its
Installed and to replace the clerks' laptop and other costs. Clerk confirmed there has not been a
Charge for room hire for the meetings that have not taken place due to the Covid-19 Virus regulations
But the saving will go towards the extra costs being incurred in the defibrillator project not covered
By the grant. If any amount is left at the end of the year it will be transferred to the Reserve Account
Before the new Precept is received. The 25% rise was agreed by all.
- 600 To receive Councillors Questions - AC questioned why the parish had not received any of the
Roos Wind Farm CIC Funding and advised that all Councillors will be emailed the details of the fund
To see if any of the criteria can be met to apply for funding and suggested the flower planters instead
Of them being funded by the Councillors. The fund will be open for submission to apply between
January - April 2021.
PJM queried the reason the village hall has not progressed any further DE discussed problems
Regarding ownership of the building and potential costs for any of the options available and the
Misunderstanding over what had been previously agreed, PJM will set up a Residents Committee to
To move this project forward.
AC asked for an update on the Defibrillator project and apologised for not replying to a request
The Clerk sent to all Councillors for help with the project that none replied to. Clerk advised the
Feeder pillar needed for the telephone kiosk had been purchased and was waiting to be
Installed. Problems still need to be sorted with the energy supply company who will not respond
To requests. DE advised a quote has been requested to replace the glass panels on the kiosk
And if the Company is able to do it, Clerk will forward details to Councillors for consideration.


